Zions Bancorporation Successfully Implements Orbograph's Automation 08 Recognition Service

Software as a Service (SaaS) model meets price/performance objectives

At Zions Bancorporation, the Automation 08 service is part of an implementation for regional capture centers running the Metavante Image Solutions' VisionIP image capture platform.

"Zion's check processing strategy targeted a reduction to our cost structure," explained Marc Keller, Senior Vice President – Item Processing Division Manager for Zions Management Services Company, a subsidiary of Zions Bancorporation.

"With volumes declining and cost in mind, we evaluated a number of solutions on the market. It became clear that we needed to minimize capital investment and ensure a solution that could drive costs and manual processes out of the backoffice workflow. Orbograph's Automation 08 service met our strict price/performance objectives as well as provided an effective Software as a Service (SaaS) pricing model."

Operationally, this solution will eliminate all but 2% of the Amount Field data entry requirements for Zions. It will also significantly reduce balancing costs by attaining 99% accuracy. Miskey rates combined with recognition engine performance typically only provide 98% accuracy. Global Concepts benchmark studies have indicated that balancing costs are equivalent to \$0.186 for every misread/miskeyed item, resulting in additional costs of \$46,500 per year for every 100,000 items.

"The Automation 08 model provides a unique processing solution for financial institutions and service bureaus with its attractive expense reduction proposition," stated Andy Leonhardt, Vice President of Sales for Orbograph. "Since this service can be installed in a branch, regional or centralized capture environment, while still assuring highest accuracy and fast cycle times, our end-user clients have been very interested in implementing it as part of their cost-containment programs."
